



2018 Annual Fire Safety Report

The University of Wisconsin Colleges is committed to providing its students and staff with a safe environment in which to live, study and work. As part of this commitment, in 2017, each Residence Hall undertook a stringent annual review of its fire safety program including policies and procedures for conducting fire and evacuation drills, the inventory and maintenance of fire detection and suppression systems, and in-service training for students and staff. This practice will continue in 2018 as the UW Colleges become Branch Campuses of UW System four-year comprehensive universities. Each Residence Hall conducts regular fire and evacuation drills pursuant to federal, state and local statutes. The purpose of conducting fire drills is to familiarize students and staff with the closest evacuation points of the buildings they are in at the time a fire alarm sounds, and to ensure the orderly and complete evacuation of the building in the event of an actual emergency and/or the activation of a fire alarm. Fire Protection Systems

Campus	Description of System
UW Baraboo/Sauk County	The Villas at Baraboo does have a sprinkler system. Fire extinguishers are strategically placed throughout the facility. Training is provided on the use of the extinguishers each year. The fire alarm system is up-to-date and tested quarterly. The local fire department also conducts periodic and regular safety checks. Residents agree to abide by all state and federal laws, and all university and The Villas at Baraboo rules and regulations and the UW-Baraboo Sauk County Student Handbook.
UW Barron County	Glenwood Commons is a smoke free facility. Smoke detector alarms and fire extinguishers have been installed as required by law. Residents agree to abide by all state and federal laws and the Glenwood Commons Handbook for Conduct and House Rules.
UW Fond du Lac	Vue Campus Housing does have a sprinkler system. Fire extinguishers are strategically placed throughout the facility. Training is offered to staff during the testing by the fire department. The fire alarm system is up-to-date and tested annually and sprinklers are tested annually. The local fire department also conducts periodic and regular safety checks. Residents agree to abide by all state, federal laws as well as all university and Vue Campus Housing rules and regulations.
UW Fox Valley	The Fox Village does have a sprinkler system. Fire extinguishers are strategically placed throughout the facility. Training is offered to staff during the testing by the fire department. The fire alarm system is up-to-date and tested annually and sprinklers are tested annually. The local fire department also conducts periodic and regular safety checks. Residents agree to abide by all state, federal laws as well as all university and Fox Village rules and regulations.
UW Marathon County	Marathon Hall does not have a sprinkler system. Fire extinguishers are strategically placed throughout the facility. Training is provided on the use of the extinguishers each year. The fire alarm system is up-to-date and tested quarterly. The local fire department also conducts periodic and regular safety checks. Residents agree to abide by all state and federal laws, and all university and Marathon Hall Rules and regulations as outlined in UW-Marathon County publications and the Marathon Hall Handbook. UW Marinette	UW-Marinette Student Apartment Housing does not have a sprinkler system. Fire extinguishers are strategically placed throughout the facility. Training is provided on the use of the extinguishers each year. The fire alarm system is up-to-date and tested quarterly. The local fire department also conducts periodic and regular safety checks. Residents agree to abide by all state and federal laws, and all university and rules and regulations are outlined in the UW-Marinette Student Housing Rights & Responsibilities Handbook.
UW Marshfield/Wood County	Bluffstone, LLC is a private, for profit business providing housing to students at UW-Marshfield/Wood County. This building is equipped with smoke detectors and fire extinguishers in every apartment and the common areas.

	There is a full sprinkler system in the building. Residents agree to follow all rules in the handbook.
UW Richland	Meyers Hall was built in 1994. This building is equipped with smoke detectors and fire extinguishers in every apartment. This building was retro-fitted with a sprinkler system in 1999 when Deans Hall was constructed. Deans Hall and Meyer Hall adjoin and are connected to the same sprinkler system. Deans Hall was built in 1999. This building is equipped with smoke detectors in every sleeping room and common area. There are two wings and two stories to this building. Each wing has a kitchen. All kitchens and other common areas are equipped with fire extinguishers. Deans Hall has a wet/dry sprinkler system. The sprinklers are heat activated. This system is inspected quarterly by Dave Jones Plumbing. The fire panel is inspected annually by SimplexGrinnell. All fire extinguishers are tested annually by Kickapoo Fire, and all Campus View staff members have been trained to use them. Students in Deans Hall are not allowed to have open flames, halogen lamps, incense, microwaves, George Foreman grills or exposed coil cooking units in their rooms. An oven, microwave and toaster are available in each kitchen. Foreman grills may be used in the wing kitchens. Students in Symons and Meyer Halls are provided with an oven but bring their own microwave, toaster, and Foreman grill, if desired. Open flames, incense and halogen lamps are not permitted.

Evacuation Procedures

All persons must evacuate the residence hall building when the fire alarm sounds. Please stay out of the way of emergency officials. Do not attempt to re-enter the building until the residence life staff or the fire department have given clearance to return to the building.
