The Federal Direct Parent Loan for Undergraduate Students or PLUS Loan is available to the parent of a Dependent student aid applicant (as determined through the Free Application for Federal Student Aid or FAFSA process).

The UW Colleges Student Financial Aid Office will process this request, transmitting the information to the US Department of Education for approval of the loan through a credit check on the parent borrower:

If approved for credit, the parent borrower will be contacted via letter by the UW Colleges Student Financial Aid Office with instructions on how to complete a Direct Parent PLUS Loan Master Promissory Note (MPN) so the loan can fully process and be applied toward the student's educational charges at the University of Wisconsin Colleges. Please wait to be contacted by our office before completing a Direct PLUS MPN.

If denied for credit, the parent borrower will be notified only by the US Department of Education as to the denial and the available options, including appealing the denial. Notification of the denial may be in the form of a letter mailed to the parent's home address; or if the parent indicated electronic notification, an email will be sent to the parent instructing the parent to log in to www.studentloans.gov to print a copy of the denial letter from the website. The UW Colleges Student Financial Aid Office will cancel (reduce to \$0.00) the Direct Parent PLUS Loan on the student's aid package when denied. If an endorser is obtained or the parent is later approved for credit, the US Department of Education will require the parent borrower to complete PLUS Loan counseling. Upon the school's receiving notification of appeal and PLUS Loan counseling being completed, the Direct Parent PLUS Loan will be reinstated for the original amount requested on the PLUS worksheet, but not to exceed the student's eligibility.

- I am aware that the PLUS Loan proceeds will be credited to my student's account at UW Colleges. If the PLUS proceeds create a credit balance on the student's account, the excess funds will be sent to the parent borrower.
- If the Parent PLUS Loan is denied, it is the student's responsibility to initiate the request for an additional Direct Unsubsidized Loan by attaching the Direct Parent PLUS Loan denial notice issued by the US Department of Education to a completed 2018-2019 UW Colleges Federal Direct Student Loan Request Form.
